# **Tabor 100 2023 Crystal Eagle Award Honorees**

Tabor 100 has grown significantly

in the last several years. From a small gathering in the basement of a church to a monthly meeting at a larger Senior Citizens Center venue to our own space in Tukwila, capable of accommodating the more than 100 persons who attend our monthly meetings. We are advocating for the Black and other minority businesses in the community at every step of the way and intend to continue these efforts into the future. Our honorees

for the 2023 Crystal Eagle Award are working diligently to create success in the community as well. Some have been directly involved as Tabor 100 members while others have collaborated with us on their way to creating positive community outcomes. We salute the efforts of our award winners and urge you to attend our annual Gala on September 30 to further both Tabor 100 and our awardees on our collective path to better the Black business community.

While **Leslie Jones** has worked on behalf of Tabor 100 and the African American community for decades, one of her biggest accomplishments was to help Tabor 100 establish our HUB Business Center. Because of Leslie's commitment to our organization, Sound Transit became the first contributor to our new building, allowing us to secure it much earlier than we had anticipated. Thank you, Leslie.



**Paula Sardinas** has established herself and FMS Global Strategies as a "force to be reckoned with" in Olympia and beyond. As one of the first African Americanowned lobbying firm in Olympia, she has exceeded expectations in advocating for our community on the western and eastern sides of the state. In a relatively short period of time, FMS Global Strategies under the leadership of Paula, has advocated for policies that benefit Black and other minority communities and fought successfully against legislation that would be detrimental to us.



**Lewis Rudd**, President and Founder of Seattle-based Ezell's Fried Chicken, has been a devoted Tabor 100 participant since the beginning of the organization. He has supported Tabor and other minority community efforts for many years, providing free meals, strategic business advice to other entrepreneurs and, recently, establishing "Rudd's R.U.B.B. (Raising Up Black Businesses). For the third year in a row, Rudd has gathered the state's most prominent Black business leaders and experts in the field with entrepreneurs striving to create and grow their own businesses. At substantial expense, Rudd has hosted this event, which has provided a springboard to success for many in the Black business community.



The Casey Family Foundation, based here in Seattle, operates in all 50 states and in 2022 spent \$127 million in pursuit of safely reducing the need for foster care and Building Communities of Hope where families have the support and opportunities they need to raise safe, happy and healthy children. **Antoinette Malveaux**, Managing Director of Strategic Engagement and Initiatives, is a 20 year veteran of the Foundation and is very much deserving of the Tabor 100 Crystal Eagle Award for Educational Excellence. She has worked diligently on initiatives to promote the health and welfare of minority communities. To name a few, she has worked to build mayoral capacity across the nation to focus on reducing violence-related deaths of African American males and supported the capabilities of tribes to prevent suicides of Native American youth. In addition, she has worked to build multi-sector collaborations focused on strengthening the educational pipeline to improve academic outcomes for boys and men of color and continues to lead a diversity of programs to improve the safety and well-being outcomes for children, youth and families.



Pacific Communications Consultants, Inc, founded and currently run by **Regina Glenn**, has promoted minority business in contracting for several decades. Whether it be Sound Transit, Port of Seattle, WSDOT and an endless list of private companies, Regina has worked on some of the largest projects in the state, ensuring Black and other minority businesses have access to the dollars spent to build the projects. Regina has also been a devoted Tabor 100 member, serving as an advisor and mentor to many Tabor members and the organization itself. She has epitomized the ideals of the organization. Regina's imprint on this region has been significant whether it be the International Arrivals Facility at Sea-Tac, the Convention Center, Africatown or the WSDOT Mega Programs, she has worked tirelessly to ensure equitable outcomes.



**Efrem Fehasa** was born in Eritrea and came to Seattle when he was 5. Coffee and the coffee ceremony was a big part of his family history as it is with many East Africans. From that experience and occasional trips back to Eritrea where he witnessed unique coffee houses that served as social centers, he created Boon Boona, his anchor coffee shop in Renton. Fehasa was determined to ensure his shop could serve as an asset to the community as well as fulfilling his passion for coffee and an entrepreneurial spirit. Boon Boona now has multiple locations and recently received financial backing from ex-Seahawk Doug Baldwin and actor Hill Harper.



The Family First Community Center opened its doors in June of this year. Foundation Executive Director and former Seattle Seahawk **Doug Baldwin** began the journey toward creation of the 26,000 square-foot facility decades ago when he witnessed a need for providing services that were at one time out-of-reach for many of those who frequented that part of Renton. His vision was to create a place where families, including youth, parents and grandparents would want to come to engage in recreation, medical care, fitness, education, arts, technology and other activities that would uplift individuals and enhance the community. Doug is very much deserving of the Crystal Eagle Award for Community Service.
